Ms. Maneri, responded that it was pending approval for the LLC name. She would pay for the insurance once the permit was approved.

Mr. Haro explained that this was a grant opportunity that we had and was something that came around every three to four years. This was specific to pavement preservation. Our match would be estimated at

\$32,285 which was tentatively put into our budget. He explained that ADOT would provide 100% of the engineering. This was an opportunity to preserve the runway.
