# 1 .<u>Discussion and Possible Recommendation To The Mayor And Council, To Amend The Zoning Code Of The City of Bisbee, Article 9.19 And To Amend The Zoning Code's Use And Zone Matrix,</u>

Public Hearing. This is a Public Hearing for the consideration of amending the "City of Bisbee: Uses and Zone Matrix" located in the Appendix of the Zoning Code so that it will indicate that bed and breakfast type lodging is an allowed use for residentially zoned properties and amend Article 9.19 the Zoning Code's definition of Bed and Breakfast by eliminating the words "and breakfast only". Currently, bed and breakfast lodging is specifically allowed only on property having commercial zoning. This amendment if adopted, would recognize bed and breakfast, as an allowed use for parcels that are zoned R-1, R-2 & R-3.

## 2. <u>Discussion and Possible Recommendation To The Mayor And Council, To Amend The Zoning Code Of The City of Bisbee, Article 9 To Include A Definition for "Building Site".</u>

Public Hearing. This is a Public Hearing for the consideration of amending Article 9 of the Zoning Code. This amendment if adopted, would establish a definition for the term "Building Site" as used Bisbee's Zoning Code.

## 3. <u>Discussion and Possible Recommendation To The Mayor And Council, To Amend The Zoning Code Of The City of Bisbee, Article 6.8 A&D</u>

Public Hearing. This is a Public Hearing for the consideration of amending the Zoning Code Article 6.8 A & D so as to prohibit unscreened outdoor storage from any side yard and to update The list of items in 6.8A that are specifically precluded from being defined as permanent outdoor storage.
