

**First Amended Subscriber Agreement Between
City of Bisbee, AZ ("Participant") and SEACOM for
Regional 911 Communications**

WHEREAS, dispatch services for law enforcement, fire, and emergency medical services in Cochise County have been provided separately by Cochise County, each independent municipality, and several fire districts; and

WHEREAS, Cochise County (the "County") and the City of Sierra Vista ("Sierra Vista"), in a desire to improve dispatch services in the County and minimize response time for law enforcement, fire and emergency medical services, thus providing better public service; and desiring to improve efficiencies in how dispatch services are provided and achieve an economy of scale to eventually reduce the overall cost of dispatch services to multiple jurisdictions within the County, entered into an IGA (the "IGA") to consolidate dispatch services in Cochise County through the creation of a consolidated emergency services communication center known as the "Southeastern Arizona Communications Center ("SEACOM")"; and

WHEREAS, SEACOM became operational on July 18, 2018; and

WHEREAS, in establishing SEACOM, both the County and Sierra Vista anticipated that additional municipalities, fire districts and other entities would join SEACOM as Participants, either as a Partner or as a Subscriber, as those terms are defined in the IGA; and

WHEREAS, concurrent with execution of this Agreement, the Subscriber has accepted the IGA (Exhibit A) to agree to become a Subscriber; and

WHEREAS, the Participant elects to expand its part-time service from SEACOM to full-time service; and

WHEREAS, the parties hereto have the authority to enter into this Agreement pursuant to A.R.S. § 11-952.

NOW, THEREFORE, the Participant, City of Bisbee, AZ, for itself and through Sierra Vista as Fiscal Agent, hereby agree as follows:

1. The term of this full-time Agreement commences July 1, 2023, and terminates June 30, 2028 (5 years). Either party may terminate this Agreement before said termination date only upon the terms set forth in the IGA.
2. Effective July 1, 2023, Participant will pay \$126,950 annually as defined in this agreement and attached as Exhibit A. At that time, Participant will begin Partner status and a position on the Joint Powers Authority (JPA) Board.
3. The terms of this First Amended Subscriber Agreement supersede and replace corresponding provisions set forth in any Subscriber Agreement previously entered into between the Parties.
