#### **NOTICE OF PUBLIC MEETING OF THE CITY OF BISBEE MAYOR AND COUNCIL FOR THE PURPOSE OF RATIFYING PAST ACTION TAKEN**

NOTICE IS HEREBY GIVEN TO THE GENERAL PUBLIC OF THE CITY OF BISBEE, COUNTY OF COCHISE, STATE OF ARIZONA, THAT THE MAYOR AND COUNCIL WILL HOLD THEIR REGULAR SESSION ON **TUESDAY, APRIL 2, 2017 AT 7:00 PM** IN THE BISBEE CITY HALL BUILDING, 915 S. TOVREAVILLE ROAD, BISBEE, ARIZONA AND AT THAT MEETING COUNCIL INTENDS TO RATIFY THE APPROVAL OF ACTIONS TAKEN AT THE **MARCH 5, 2019, REGULAR SESSION.**

THE ITEM THAT WILL BE INCLUDED ON THE AGENDA FOR RATIFICATION OF ACTIONS TAKEN AT THE REGULAR SESSION OF MAYOR AND COUNCIL ON **TUESDAY, APRIL 2, 2017 AT 7:00 PM.** THIS ACTION INVOLVED:

- **ON MARCH 5, 2019, AT A REGULAR MEETING OF THE COUNCIL, UNDER AN AGENDA ITEM WORDED AS DISCUSSION AND POSSIBLE ACTION REGARDING THE EMPLOYMENT STATUS OF ROBERT SMITH, THE COUNCIL, BY A 5-2 VOTE, VOTED TO ADOPT A PRELIMINARY RESOLUTION TO TERMINATE HIM AS CITY MANAGER, WITHOUT CAUSE, PURSUANT TO CHARTER SECTION 3.09. ONE EFFECT OF THIS RESOLUTION WAS THAT THE CITY MANAGER, MR. SMITH, WAS ALLOWED THREE MONTHS OF SEVERANCE PAY FROM THE DATE (MARCH 5, 2019) THAT THE COUNCIL ADOPTED THE PRELIMINARY RESOLUTION.
